UK Fisheries Science Advisory Panel: Advice Output Sheet

Subject: Review the joint evidence-based advice provided by NE/Cefas/JNCC entitled: What are the ecosystem risks and benefits of full prohibition of industrial sandeel fishing in the UK waters of the North Sea (ICES Area IV).

Section 1: Advice Summary

The joint NE/Cefas/JNCC response to evaluate the risks and benefits of full prohibition of industrial sandeel fishing in UK waters of the North Sea is comprehensive and thorough. Benefits to commercial finfish stock biomasses are limited, with both positive and negative responses.

However, sandeel availability has been linked to seabird breeding success and survival; with the joint report indicating that seabirds would be the biggest beneficiaries if sandeel biomass were to increase as a consequence of a full prohibition of industrial sandeel fishing in UK waters of the North Sea.

The summary of ecosystem risks and benefits is usefully tabulated.

The UKFSAP Chair received the document produced by NE/Cefas/JNCC in response to Defra's advice request on 27th October 2022 from Defra's Fisheries Science and Evidence Delivery Team. The document and Defra's fast-track advice request were forwarded by the UKFSAP Chair to panel members on 28th October 2022 ahead of the scheduled monthly meeting of UKFSAP.

The document was reviewed by UKFSAP and comments sent to the Chair with an agreed deadline of 4th November 2022. The Chair collated the responses received, initially drafted UKFSAP's advice based on the reviews and circulated to panel members and the UKFSAP Secretariat on the morning of the 7th November 2022, ahead of the next scheduled UKFSAP meeting on the afternoon of that day.

At its meeting on the 7th November 2022, UKFSAP discussed and agreed the draft advice for finalisation no later than 8th November 2022. Invited experts were in attendance at the meeting in order to clarify any issues – Mathieu Lundy (AFBI), Ewen Bell (Cefas), Jacob Bentley (NE), Mark Duffy (NE), Libby West (NE) and Declan Tobin (JNCC); together with Rob Cook (Defra) and Gemma Cripps (Defra) who coordinated the advice request.

The participation of the external experts assisted UKFSAP in its review and generated a healthy discussion which all agreed would strengthen the advice. UKFSAP concluded that generally the paper was comprehensive and that the evidence and analysis used are sound.

The panel's reviews ahead of the meeting were collated into an annotated document (*available from the UKFSAP Secretariat*) where responses to comments raised during the meeting were noted. UKFSAP agreed with the experts that the definitions in the paper need to be tightened up and to be more specific with some statements to avoid ambiguity and possible confusion. The experts agreed to revise the initial paper and resubmit by 11th November 2022 addressing the comments raised by UKFSAP.

UKFSAP to agree their draft advice on 8th November 2022 by email.

<u>Section 2.3.3.</u>: Additional reference added. Comment about linkage to be addressed. Great Britain? Northern Ireland?

<u>Section 2.3.4.</u>: Change of heading. Minor textual edits.

<u>Table 2</u>: Minor heading change.

<u>Section 3.1.1.</u>: More substantive textual edits and comments to be addressed. How many years are the simulations projected for?

<u>Section 3.1.2.</u>: Why is this needed? May require reordering of later section (e.g. 3.2.2.).

<u>Section 3.2.1.</u>: How many years are the simulations projected for? Minor textual edit.

<u>Section 3.3.</u>: Minor textual edits. Possible reference missing to NE modelling work.

<u>Section 3.4.1.</u>: Is the accuracy justified in the text; e.g. *between 1% and 3%*? Minor textual edits. Is it necessary to have both tables 3 and 4?

Section 3.4.2.: May require require moving text.

Section 4.1.: Minor textual edits.

Section 4.2.: Heading change.

Section 4.3.: Minor textual edits. Possible text deletion.

Section 4.4.: Minor textual edit.

Section 5.: Comment wrt predators.

Section 5.1.: Minor textual edit.
