I agree with Larry. As well, I searched the Virtual Data Center for data concerning the known Nov-Dec distribution of alewife. The area around Tiverton is poorly resolved in the research surveys. Appropriate monitoring for fish presence during the period of activity might be prudent.

Andrew, I can be fairly certain that we are unlikely to have information at hand to suggest the November-December use of the area in question by diadromous species.

My guess would be that few (if any) diadromous species would be residents of the passage during the months in question (I also doubt it would even be a significant migratory route at other times of the year.). Certainly the fewness and habits of either inner or outer Bay of Fundy origin mature Atlantic salmon, and the absence of archival near shore reports of non-maturing individuals in late fall/ early winter months in that area would suggest a low probability of their occurrence there.

I have copied your request to Rod in the event that he has other insights on the marine distribution of non-salmon diadromous species around Tiverton in Nov/Dec.
