FYI. From my involvement with a quarry monitoring board I am acquainted with the details of a 'blasting

design. It will provide details on the number of holes drilled, depth, charge size and expected tonnage of rubble created. It will not provide any information on sound conductance through the underlying bedrock, nor propagation distance. That is highly dependent on the fractures within the rock formation. In the case of marine mammals, unless knowledge is held in terms of the degree to which the formation extends into the B of F and the amount of overlying loose material on the seabed, it will be very difficult to predict the amount and frequency of noise in the water. An associated question is the transference of sound from the rock to water, and the noise levels that will affect the various marine mammal species in the Bay. The next factor will be the distance that such noise will travel in water and at what frequency and decay. Only then will an assessment be possible of the potential impact on right whales (or any marine mammals).

I agree with Faith. Who do we have who has the information and expertise to do such an assessment? Certainly no one in MFD.
