**Subject:** FW: Deltaport rail issues

Michael, this issue appears to be gaining momentum. Both Langley and Surrey have raised significant concern regarding rail and truck traffic issues resulting from the proposed deltaport expansion. The CEAA Scoping document and Application ToR both do not specifically define the spatial boundaries required for a Traffic Impact Assessment, however, the Noise Impact Assessment is defined west of 156th St in Surrey.

for discussion:

1. The EAO has extended the Public Consultation Period and provided extra opportunities for Langley to participate in the review process when they have not formally adopted a project scope which would commit them to addressing these concerns. At the last Public meeting the EAO position was that the DP3 was not a linear project and that rail/traffic issues west of 156th St were not consider as within the scope of project for this EA. Will the CEAA Comprehensive Study process be left to deal with these issues?
2. Should EC/DFO/CEAA and EAO meet to discuss how to formally address traffic issues in Surrey/Langley for the current EA in terms of scope and how VPA addresses these issues.
3. DFO's current position is to refine the scope of project to our regulatory triggers - this is clearly beyond our mandate and I would expect Ottawa to be reluctant to officially adopt a broader scope even with the current flexibility in the federal scope.
