

("St. Clair"), Dawn to Lake Erie Pipeline & TransCanada Pipelines Limited ("TransCanada"), Lake Erie Crossing ("Collectively referred to as the "Canadian Millennium Project" or the "Project"): Requests to Reconsider Proposed Environmental Assessment Process

In its previous letters dated 27 October and 13 November 1998, the Board had indicated that it would, in due course, finalize the scoping process which had been initiated in respect of the Canadian Millennium Project and that it intends to ensure that a comprehensive study report is conducted in accordance with paragraph 21(a) of the Canadian Environmental Assessment Act ("CEAA").

By letters dated 27 November and 10 December 1998, TransCanada and St. Clair have requested that the Board and the Canadian Environmental Assessment Agency (the "Agency") reconsider the Board's 27 October 1998 process determination pursuant to section 21 of the CEAA.
