Hi Wendy,

I'm still working at home and I can't access the CEAA site so I need your advice/assistance concerning the White's Cove Digby Quarry and Marine Terminal.

Referral File No. 03-HMAR-MA8-000-000020.

This is such a politically hot project that I don't want to make any wrong decisions. I talked with the assessor and he

asked if I could get some clarification.

Here's the scenerio:

- Feb./03 - NWP Trigger (at this point DFO is the lead)
- Feb./03 - FCR's distributed by HMD
- March 31/03, meeting chaired by CEAA with all agencies (Provincial & Federal) involved with quarry proposal
- Comprehensive Study is most likely as opposed to Panel Review (but may change)
- Draft Scope (to be developed jointly within the next two weeks) will be made available for public comment to determine the extent of public participation.
- once the time period for public review of the Draft Scope of Project is complete, it will then be determined if a Panel Review is relevant.

**MY QUESTIONS:**

Can the EA Screen be started (NWP Trigger Notification as start date) with the selection of Comprehensive Study?

What happens with the above EA Screen/File if it is determined that the project will be moved to a Panel Review?
